RE: Roof Repairs-2900 Gulf Shore Blvd N

West Coast Florida Enterprises, Inc. proposes to furnish all equipment, labor, and materials necessary to complete the work as detailed below:

### **SECTION 1 WEST BUILDING:**

- Remove all debris from roof.
- Repair damage to roof membrane in twenty-four areas.
- Replace missing fasteners on two equipment hoods.
- Install new flashings around three vent pipes.
- Remove and install 16ft. of caulking on counter flashing.

## The total price for the above scope of work is \$2,400.

(Two Thousand Four Hundred Dollars)

#### **SECTION 2 NORTH BUILDING:**

- Remove all debris from roof.
- Apply new sealant on one pitch pan.
- Caulk one conduit line going through wall panel.
- Seal one expansion joint behind conduit line.
- Repair damage to roof membrane in thirteen areas.
- Repair three areas on wall flashing.

## The total price for the above scope of work is \$2,400.

## **SECTION 3 SOUTH BUILDING:**

- Remove all debris from roof.
- Repair damage to roof membrane in twenty-five areas.

## The total price for the above scope of work is \$2,300.

(Two Thousand Three Hundred Dollars)

#### **SECTION 4 MAIN OFFICE BUILDING:**

• Install one new patch over areas where previous temporary repair was performed.

## The total price for the above scope of work is \$950.

(Nine Hundred Fifty Dollars)

#### **SECTION 5 BIKE SHOP:**

- Patch one hole in roof membrane.
- Install two new patches over areas where previous temporary repairs were performed.

#### The total price for the above scope of work is \$950.

(Nine Hundred Fifty Dollars)

#### **SECTION 6 POOL HOUSE:**

• No repairs are needed on the roof currently.

## The total price for all the above scopes is \$9,000.

**Terms:** A signed proposal along with 30% of the total payment must be received in our office before the work can be scheduled. The remaining balance will be due upon completion of the work.
